The Moulton Niguel Water District is preparing a Mitigated Negative Declaration for the project described below. A "Draft" Mitigated Negative Declaration is on file at the MNWD office, located at 27500 La Paz Road, Laguna Niguel, California, and is available for public inspection. In compliance with the California Environmental Quality Act (CEQA), MNWD has prepared a Mitigated Negative Declaration to address the potential environmental effects of the proposed project. The Mitigated Negative Declaration is available for a 20-day public review period from June 17, 2009, to July 6, 2009.

The Mitigated Negative Declaration will be considered for approval or disapproval by the MNWD Board of Directors at a meeting, to be held on July 16, 2009, at 1:30 p.m. at the following location 27500 La Paz Road, Laguna Niguel, CA. Written comments from members of the public or other interested parties on the Mitigated Negative Declaration will be received by MNWD from the date of this notice through the conclusion of the public review period specified above. Description of Nature, Purpose and Beneficiaries of Project: The project constructs approximately 470 linear feet of C-900 PVC recycled water main, two new services, and one air/vac valve. The purpose of the project is to increase recycled water service to two existing potable water irrigation services, thereby reducing potable water demand. The project will most directly benefit the two existing potable water irrigation customers intended to be converted, but will ultimately benefit all MNWD customers by reducing the District's potable water demand.

Mitigation measures to avoid potential significant effects:

Construction will be permitted by and include traffic control coordinated with the city of Laguna Niguel. All work will be covered during non-construction periods. In the event of a water spill containing high chlorine levels for disinfection, either during construction or normal operation, MNWD staff responds by immediately isolating the leak and containing the spill to keep it from reaching the tributary stream course. The contained water volume is then discharged into the nearest sewer to be conveyed to the SOCWA Joint Regional Treatment facility. The San Diego Regional Water Quality Control Board (RWQCB) is notified as stipulated in the discharge permit. The San Diego RWQCB monitors the spills within the area.
