The Moulton Niguel Water District (MNWD) is a public agency, which provides water to the Cities of Aliso Viejo, Laguna Niguel, Mission Viejo, Laguna Hills, and portions of Dana Point. **Division 6 of the District includes, generally, a portion of the City of Aliso Viejo.** The seven members of the Board of Directors are elected and receive no salary other than a nominal *per diem* fee for attendance at meetings. The Board generally meets three times per month, and members also attend meetings on a bi-monthly or quarterly basis from time to time. Some MNWD Directors also serve on other public agency boards where MNWD is a member or participant. The Board makes decisions regarding purchase, pricing and sale of water, and sewer service, construction of new and replacement water and sewer facilities such as large pipelines and reservoirs, and interagency agreements for regional water supply facilities.

To be eligible for Board membership, a candidate must be eighteen years of age, a citizen of the State, a registered voter in the County of Orange and a <u>legal resident of Division 6 of the District.</u>
