WHEREAS, Director Larry McKenney submitted his resignation from the Moulton Niguel Water District ("District"), Division 6 Director position, to the Board of Directors ("Board") of the District on October 10, 2014, effective October 12, 2014;

WHEREAS, by letter dated October 17, 2014, the District notified the County of Orange Registrar of Voters of Director McKenney's resignation and of the Board's intent to fill the Division 6 Director vacancy by appointment within 60 days from the effective date of Director McKenney's resignation from such office, in accordance with Government Code Section 1780; and

WHEREAS, the Board has reviewed interested applicants for the Division 6 Director position and is prepared to make such appointment at a meeting of the Board on this date.

NOW, THEREFORE, the Board of Directors of MOULTON NIGUEL WATER DISTRICT does hereby **RESOLVE**, **DETERMINE** and **SORDER** as follows:

Section 1. The Board hereby appoints ______ as the Director of Division 6 of the District to fill the vacancy created by the resignation of Mr. Larry McKenney, such appointment to be effective for the remainder of the Division 6 Director term which ends December 2016, in accordance with Government Code Section 1780.

<u>Section 2.</u> The Secretary of the District is hereby directed to file a certified copy of this Resolution with the Registrar of Voters of the County of Orange and the Clerk of the Board of Supervisors of the County of Orange, and take any other necessary actions to complete the appointment proceeding described in this Resolution.

RESOLUTION OF THE BOARD OF DIRECTORS OF MOULTON NIGUEL WATER DISTRICT HONORING MR. WAYNE CLARK FOR 35 YEARS OF SERVICE TO MUNICIPAL WATER DISTRICT OF ORANGE COUNTY

WHEREAS, Mr. Wayne Clark will retire after 35 years of dedicated service from the Municipal Water District of Orange County (MWDOC) Board of Directors; and

WHEREAS, Mr. Clark during his tenure provided leadership to enhance regional coordination to address water reliability needs for communities of Orange County; and

WHEREAS, Mr. Clark served as a Director of the Irvine Ranch Water District Board from 1977 until 1981 during which time the construction of the Diemer Filtration Plant occurred benefiting many Orange County agencies including Moulton Niguel Water District; and,

WHEREAS, Mr. Clark is recognized for his involvement with Association of California Water Agencies (ACWA) since 1979 and served as an alternate representative of ACWA to the National Water Resources Association (NWRA) Board of Directors. He is a member of the NWRA Municipal Caucus, the NWRA subcommittee on climate change and the Colorado River Water Users Association; and

WHEREAS, in 1991, Mr. Clark as a Director for MWDOC, in partnership with the Orange County Water District, formed the National Water Resources Institute (NWRI) to develop new sources of water through cooperative research and technology while protecting the environment; and

WHEREAS, in 1992, Mr. Clark co-founded the Urban Water Institute (UWI), a nonprofit corporation devoted to providing information on the economies and management of water resources and under his leadership as its Executive Director, brought together water agencies throughout the State to promote cooperation; and

WHEREAS, Mr. Clark was instrumental in development of the Allen McColloch Pipeline (AMP) which provides significant water for residents of Moulton Niguel Water District;

NOW, THEREFORE, BE IT RESOLVED: The Board of Directors of Moulton Niguel Water District wishes to honor Mr. Wayne Clark for his outstanding contributions and dedication to the water industry, his exemplary leadership during his tenure on the MWDOC Board, and for his devoted service to Southern California.
