# SUMMARY:

<u>Issue</u>: Capital expenditures on qualified projects incurred between now and the anticipated FY 2017/18 bond issuance are eligible for reimbursement from bond proceeds.

<u>Recommendation:</u> It is recommended that the Board of Directors approve the resolution entitled "A Resolution of the Moulton Niguel Water District Board of Directors Declaration of Intent to Reimburse Qualified Capital Expenditures from Anticipated Bond Proceeds".

<u>Fiscal Impact</u>: Subject to final issuance date, actual capital expenditures and project eligibility, upwards of \$20 million in project costs could potentially be reimbursed with bond proceeds.

# **BACKGROUND:**

The District's Long Range Financial Plan and 10-year cashflow model identified a need for a bond issuance in early 2018 to fund the District's Capital Improvement Program. This plan was last presented during the adoption of the FY 2016-17 Operating and Maintenance and Capital Improvement Program budgets. The bond issuance is intended to manage future rate adjustments that would otherwise be necessary to maintain reserves while meeting cashflow needs of the District's Capital Improvement Program.

Bond issuances are a prudent financial tool to keep rate increases smooth by spreading capital costs over time. At the time of bond issuance, bond proceeds must be spent within 3 years under IRS rules, which effectively caps the total issuance amount. However, with the adoption of a reimbursement resolution, capital

expenditures incurred up to 18 months prior to the bond issuance can be reimbursed. Adopting a reimbursement resolution does not commit the District to issue debt in the future.

# **DISCUSSION:**

As the bond issuance approaches, project costs that are paid up to 18 months prior to the issuance are eligible for reimbursement by the bond proceeds. Finance staff has coordinated with the Engineering staff to identify eligible projects and also include language to account for when projects change. Staff recommends the Board of Directors adopt "A Resolution of the Moulton Niguel Water District Board of Directors Declaration of Intent to Reimburse Qualified Capital Expenditures from Anticipated Bond Proceeds".

## RESOLUTION OF THE BOARD OF DIRECTORS OF THE MOULTON NIGUEL WATER DISTRICT DECLARING ITS INTENT TO ISSUE TAX-EXEMPT BONDS TO BE USED TO REIMBURSE THE DISTRICT FOR EXPENDITURES PRIOR TO THE ISSUANCE OF TAX-EXEMPT BONDS

WHEREAS, the Moulton Niguel Water District (the "District") desires and intends to finance the construction of new facilities or replacement of existing facilities, including: a regional force main, reservoir improvements and management system replacement, the District's operations headquarters and other improvements to the District's Water System (the "Project"); and

**WHEREAS**, the District expects to cause the execution, delivery and sale of tax exempt obligations such as bonds, in one or more series, for the purpose of providing financing for all or a portion of the Project in a principal amount of approximately \$64,000,000 (the "Obligations"); and

**WHEREAS**, the District expects to incur certain expenditures relating to the Project and to pay for such expenditures from the District's moneys on hand prior to the execution of the Obligations (the "Reimbursement Expenditures"); and

**WHEREAS**, the District reasonably expects to use a portion of the proceeds of the Obligations to reimburse the District for expenditures made prior to the date the Obligations are entered into:

**NOW, THEREFORE** the Board of Directors of the Moulton Niguel Water District, does hereby **RESOLVE, DETERMINE** and **ORDER** as follows:

**SECTION 1.** <u>Declaration of Official Intent</u>. The District hereby declares its official intent, subject to the further approval of this Board of Directors, to use up to \$64,000,000 of the proceeds of the Obligations to reimburse itself for the Reimbursement Expenditures. It is intended that this Resolution shall constitute a declaration of "official intent" within the meaning of Section 1.150-2 of the Treasury Regulations promulgated under Section 150 of the Internal Revenue Code of 1986, as amended.

**SECTION 2.** <u>Other Approvals</u>. The adoption of this Resolution shall not bind the District to proceed with execution and delivery of the Obligations until and unless all other necessary actions and approvals are taken or received in accordance with all applicable laws.

SECTION 3. Effective Date. This resolution shall take effect upon adoption.
