SUBJECT: Operations Center Consolidation and Improvement Project -

Audio/Visual Scope of Services

DIVISION: District-Wide

SUMMARY:

<u>Issue</u>: To further the District's initiative to enhance transparency with its customers, considering video recording in development of the Operations Center Consolidation and Improvement (OCCI) Project is appropriate and timely.

<u>Recommendation:</u> It is recommended that the Board of Directors direct staff to incorporate video recording capabilities into the Board Room for the proposed OCCI project.

<u>Fiscal Impact</u>: Sufficient funds are included in the Capital Budget associated with the OCCI budget adopted by the Board of Directors.

BACKGROUND:

The District has operated from the Main Office and Plant 2A sites for more than 40 years with intermittent upgrades and improvements to both facilities to support growth or infrastructure needs. The District initiated the Operations Center Consolidation and Improvement Project in 2013 with the development of a Needs Assessment evaluating current spacing needs, future growth potential, and long-term space requirements. After completion of the Needs Assessment and a review of potential site alternatives to construct the necessary Operations Center, the District concluded that remaining at the Plant 2A site and consolidating all of the District personnel and operations into a single site was the best course of action.

Early planning efforts on the proposed project included preliminary site layout and architecture work with Ware Malcomb to develop a proposed project for further evaluation through the necessary California Environmental Quality Act (CEQA)

process, as well as the permitting with the City of Laguna Hills. The District continues to work with Ware Malcomb to advance the design of the proposed Operations Center and development of construction documents for the facility improvements. At the current stage of the project development, staff is preparing a Request for Proposals for design/build services for all low voltage work, which includes audio/visual components, data/communication, and security requirements.

DISCUSSION:

District staff provided a presentation to the District's Board of Directors at the June 12, 2017 Engineering and Operations Board Meeting to review the proposed scope for the audio/visual components of the Board Room being considered as part of the OCCI project. The scope of work included:

- Projection screens behind the Dais
- Individual monitors mounted into the Dais for Board members and staff
- Multiple inputs in the floor, Dais, and wireless connections
- Audio conferencing/recording capabilities with reinforcement from overhead, in-ceiling speakers
- Goose-neck style microphones for audio conferencing and recording

As the District is finalizing the scope of work for a design/build Request for Proposals associated with all low voltage needs for the proposed OCCI project, the District staff is proposing to include video recording capabilities in the proposed Board Room. Providing a video recording would allow members of the public to live stream District Board Meetings or watch a recording of a past meeting at their convenience, which would enhance the level of transparency and access for our customers to monitor the District's Board Meetings.

SUMMARY:

<u>Issue</u>: Consider reverting back to voting at-large.

<u>Recommendation</u>: It is recommended that the Board of Directors approve the resolution entitled, "Ordering the Reversion to At-Large Voting by Which Elections will be Conducted Beginning with the Next General District Election."

Fiscal Impact: N/A

Reviewed by Legal: Yes

BACKGROUND:

In June 1981, the Moulton Niguel Water District's (MNWD) Board of Directors adopted a resolution to change from at-large voting and created seven election divisions. Over the years, the Board of Directors reviewed the divisional voting with the last discussion taking place in 2014.

DISCUSSION:

The MNWD is a California Water District organized under California Water Code. Elections in the District are governed by a special enactment found in Water Code sections 35185 through 35195, and secondarily by the Uniform District Elections law.

Water Code section 35189 provides that by default, directors shall be elected on an at-large basis, "unless the board of directors determines that directors shall be elected by divisions." Since the formation of MNWD in 1960, elections were based

on at-large voting; however, in 1981, the Board of Directors adopted a resolution to change to divisional voting as the area was being developed and growing.

Over the years, the communities within MNWD's service area have been established and much of the infrastructure for potable, recycled and wastewater are interconnected and operated on a district-wide basis. The Board of Directors have emphasized the importance of serving all of the District's communities and make decisions that takes into account the best interest of all of our customers. In evaluating major initiatives and Board decisions over the last several years, these actions have district-wide impacts rather than limited to any one division. Going forward, we see that statewide and regional issues, as well as District priorities, all have broad impact across all of our communities.

In looking at other special districts in Orange County, of the 23 agencies, only five have voting by division. All of the South Orange County water agencies, with exception of MNWD, have at-large voting. Of the six cities that MNWD serves, five of them have at-large voting for their councils: Laguna Niguel, Laguna Hills, Mission Viejo, Aliso Viejo and Dana Point.

Transitioning back to at-large voting would allow all of the District's customers to determine the leadership of MNWD. The current staggered four-year terms that each Board member serves would not be impacted by a change to at-large voting. However, all of the District's customers would have an opportunity to vote every two years. Additionally, current and future board members will continue to represent all of the MNWD's constituents and serve all customers rather than just those in their divisions. The at-large voting would memorialize the current Board practice of deliberating and decision-making on behalf of all of the District's customers.

Water Code sections 34806 and 34807 give the Board the authority to adopt resolutions governing the business and affairs of the District, and the voting procedures of the District as a whole are within the scope of that directive. Accordingly, in order to restore the at-large voting, it would be appropriate for the District to adopt a resolution repealing Resolution No. 81-37, and restoring the District to an at-large voting. The District elections will continue to be conducted as resident voter elections under the provisions of the Water Code and the Uniform District Elections Law.

RESOLUTION NO. 17-

RESOLUTION OF THE BOARD OF DIRECTORS OF THE MOULTON NIGUEL WATER DISTRICT ORDERING THE REVERSION TO AT-LARGE VOTING BY WHICH ELECTIONS WILL BE CONDUCTED BEGINNING WITH THE NEXT GENERAL DISTRICT ELECTION

WHEREAS, the Moulton Niguel Water District ("District") is a California Water District duly formed, organized and existing pursuant to and under the provisions of Division 13 of the Water Code; and

WHEREAS, Water Code Sections 35185 – 35195 set forth the method of elections for the District. Water Code Section 35189 provides that Directors shall be elected on an at-large basis unless the Board determines that Directors shall be elected by divisions; and

WHEREAS, as the area serviced by the District was continuing to grow, the Board took action on June 18, 1981 to adopt Resolution No. 81-37 which ordered the creation of divisions for conducting elections. On that same date, the Board adopted Resolution No. 81-38 which designated divisions in which elections are to be conducted; and

WHEREAS, since the change to by-division voting in 1981, the communities within the District's service area have become established and much of the infrastructure for potable, recycled and wastewater are interconnected and operated on a District-wide basis; and

WHEREAS, the Board emphasizes the importance of serving all of the District's communities and making decisions that take into account the best interests of all customers; and

WHEREAS, in evaluating major initiatives and Board decisions over the last several years, it can be concluded that Board actions have had District-wide impacts, rather than impacts limited to any one division. Looking to the future, the Board foresees that statewide and regional issues, as well as District priorities, will likely all have broad impacts across all communities served by the District; and

WHEREAS, transitioning back to at-large voting would allow all of the District's customers to determine the leadership of the District and all of the District's customers would have an opportunity to vote every 2 years. In addition, at-large voting would memorialize the current Board practice of deliberating and decision-making on behalf of all of the District's customers; and

WHEREAS, the Board desires to take action to restore the method for District elections to at-large voting.

NOW, THEREFORE, the Board of Directors of Moulton Niguel Water District does hereby **RESOLVE, DETERMINE** and **ORDER** as follows:

Section 1. The Recitals set forth above are incorporated herein and made an operative part of this Resolution.

Section 2. Directors of the District shall be elected on an at-large basis, as provided for under Water Code Section 35189, beginning with the next general district election.

Section 3. Except as otherwise specifically set forth in this Resolution, all other laws, rules, regulations and District policies pertaining to elections shall remain in full force and effect. For example, and not by way of limitation: (a) elections shall continue to be conducted as resident voter elections in accordance with the law; (b) the current staggered 4-year terms that each current Director serves shall not be impacted by the change to at-large voting; and (c) current and future Directors will continue to represent all of the District and all of its customers.

Section 4. The General Manager, and/or her designees, are hereby authorized to take any and all actions, and execute any and all documents, which may be necessary to implement this Resolution including, for example and not by way of limitation, compliance with requirements of the Orange County Registrar of Voters. Nothing in this Section shall authorize any implementation which would constitute a material change to: (a) the action taken by this Resolution; or (b) the laws, rules, regulations and District policies that are not impacted by this Resolution.

<u>Section 5</u>. This Resolution No. 17-__ shall be effective upon adoption. As of the effective date of this Resolution No. 17-__, Resolution Nos. 81-37 and 81-38 shall be of no further force or effect.
