SUBJECT: Decision To Fill Board Vacancy By Appointment And Authorize The Posting Of A Notice Of Vacancy

SUMMARY:

<u>Issue</u>: Director Kelly Jennings resigned from the Board on December 1, 2020. Under Government Code Section 1780, the Board has the option to fill the vacancy by appointment or by calling an election.

<u>Recommendations:</u> It is recommended that the Board of Directors consider the requirements and options for filling the Board vacancy and take the following actions:

- 1. Decide to fill the Board vacancy by appointment and not call a special election; and
- 2. Authorize the posting of a Notice Of Vacancy.

<u>Fiscal Impact</u>: Costs would include the time and resources for posting the Notice and conducting interviews to fill the vacancy. The cost of calling and conducting an election would be substantial and could not be estimated without further input from the Registrar of Voters.

Reviewed by Legal: Yes.

BACKGROUND:

Under Government Code Section 1780, the "Date of Vacancy" is deemed to be either the date on which the Board is notified of the vacancy or the effective date of the vacancy, whichever is later. In regard to Director Jennings' resignation, the Date of Vacancy is December 1, 2020.

The Board may make an appointment within 60 days after the Date of Vacancy. Therefore, the Board has until Monday, February 1, 2021 to fill the Board seat by appointment (60 days is Saturday, January 30, so advance to February 1 for the first business day thereafter). A Notice Of Vacancy must be posted in three or more conspicuous places in the District at least 15 days before the Board makes the appointment. Such a notice is commonly posted at a district's headquarters and/or community/library buildings. Although not required by law, districts usually issue a press release and provide notice to the public through the district's website, social media, etc. The procedure for interviews and the appointment are explained in the Notice. A draft of the Notice is enclosed with this Staff Report.

In lieu of making an appointment, the Board may call an election to fill the vacancy within 60 days of the Date of Vacancy. Since this would be a special election, it would likely be cost prohibitive. Of course, if the Board does wish to pursue this approach, Staff can reach out to the Registrar of Voters and provide further details at a subsequent meeting.

If the Board has not filled the vacancy by appointment, or if the Board has not called for an election within 60 days of the Date of Vacancy, then the Board of Supervisors may appoint a person to fill the vacancy within 90 days of the Date of Vacancy, or the Board of Supervisors may order the District to call an election to fill the vacancy. If within 90 days of the Date of Vacancy, neither the MNWD Board nor the Board of Supervisors have filled the vacancy, and no election has been called, then the MNWD Board is required to call an election to fill the vacancy.

DISCUSSION:

Pursuant to Election Code Section 10554, Board members take office at noon on the first Friday in December next following the general district election. Therefore, the Directors who were up for election on November 3, 2020 took office December 4, 2020 (there was no election, these Directors ran unopposed). As a result, as of the Date of Vacancy (December 1), Director Jennings' seat was technically still in the first half of its current term until December 4, 2020.

The current term for Director Jennings' seat runs from 2018 to 2022. Since the Board vacancy occurred in the first half of a term of office (2018-2020), and at least 130 days prior to the next general district election (November 8, 2022), the person appointed to fill the vacancy holds office until the next general district election. The next general district election is November 8, 2022 which is indeed scheduled 130 or more days after the Date of Vacancy.


